3. If an inspection of the consignment is deemed necessary, it is requested that:
 - the inspection of the consignment is carried in an area out of sight of persons, who do not have a Need-to-Know, and in the presence of the Courier,
 - the Courier is assisted in re-packing the consignment immediately upon completion of the examination,
 - evidence of the opening and inspection of the consignment is provided by sealing and signing the outer envelopes of the consignment after having them closed again and by annotating in the shipping Documents that the consignment has been opened.
4. Customs, Police, and / or Immigration Officials of the country of origin or destination of the consignment, or countries to be crossed give assistance as necessary to assure successful and secure delivery of the consignment.

Notes for the Courier

Certificate No.

You have been appointed to repeatedly carry / escort classified consignments.

Your "COURIER CERTIFICATE" has been provided to be used within the period of time indicated on the Certificate.

You have been briefed on your obligations related to the transfer of classified consignments and you have signed an appropriate briefing declaration.

The following general points are brought to your attention:

1. You will be held liable and responsible for the consignment described in the individual "Descriptions of Shipment".
2. Throughout the travel, the consignment must, under any circumstances, be kept under your personal custody and must not be left unattended unless it can be deposited under secure conditions.

During overnight stops, governmental facilities or industrial companies having appropriate security clearance may be utilised. You are to be instructed on this matter by your responsible Security Officer.

3. The consignment will not be opened en route, and the contents must not be displayed or disclosed to third persons except in the circumstances described in paragraph 8 below.
4. You are not allowed to deviate from an agreed route and travel schedule unless explicitly approved by authorised persons.
5. In cases of emergency, you are supposed to take such measures as deemed necessary to protect the consignment.
6. You are requested to ensure that you have all the necessary personal travel Documents (travel tickets, currency, medical insurance certificates or other necessary medical certificates) available, and that your expatriation and identification Documents (passport, visa, ID card) are complete and valid.
7. The consignment will only be handed over or delivered to authorised personnel of the recipient as specified on the "Declaration of Shipment" or other appropriated dispatching notes.
8. There should be assurance of immunity from search by the Customs, Police, and/or Immigration Officials of the various countries whose borders you will be crossing.

In case such officials require access to the consignment you are supposed to provide to them your "Courier Certificate" and this Note, and you should insist on this documentation being immediately passed to senior Customs, Police and/or Immigration Officials.

In case Customs, Police, and/or Immigration Official demands to access the contents of the consignment you are required to inform your responsible Security Officer.

9. Upon return from the travel you are required to provide a bona fide receipt for the consignment signed by duly authorised security officials of the recipient, and to sign the declaration in **"Declaration by the Courier on Completion of the Carriage / Transport"**.
